	ONE (1) competitor born 1996 - 1997 (Juv. A) or later*, no more than 64 kilograms
	ONE (1) competitor born 1994 - 1995 (Juv. B) or later*, no more than 90 kilograms
	ONE (1) competitor born 1991- 1993 (IJF Junior) or later*, no weight limitation

FEMALE	ONE (1) competitor born 2000 - 2001 (Int. 1) or later *, no more than 43 kilograms
	ONE (1) competitor born 1998 - 1999 (Int. 2) or later *, no more than 53 kilograms
	ONE (1) competitor born 1996 - 1997 (Juv. A) or later *, no more than 64 kilograms
	ONE (1) competitor born 1994 - 1995 (Juv. B) or later *, no more than 70 kilograms
	ONE (1) competitor born 1991- 1993 (IJF Junior) or later *, no weight limitation

Winners in each division will be guaranteed a spot on the team. The winner will compete at the USJF/USJA Jr. National Team Competition to be held on Sunday, July 4, 2010. In the event the winner can not compete the spot will go to the second place winner. All Team members will receive a team uniform specially prepared for this event.

### **Contest Rules:**

**All matches will be conducted using the current International Judo Federation Contest Rules with the following modifications:**

- **Modified Double Elimination 6 or more contestants and Round Robin 5 or less contestants.**
- **Pre-1994 rules regarding Safety Zone and Out of Bounds area in all divisions.**
- **Pre-2003 medical rules in a divisions.**
- **Shime-waza (choking techniques) Juv. A, B and IJF Junior divisions only.**
- **Kansetsu-waza (arm lock techniques) IJF Junior division only.**
- **Match length – Int. 1, Int. 2 and Juv. A, 3 minutes.**
- **Match length – Juv. B and IJF Junior, 4 minutes**
- **Golden score (sudden victory) 2 minutes all divisions.**
- **White gi is mandatory, Blue gi is optional for blue side only.**
