Tournament Rules

All matches will be conducted using the current Contest Rules for Judo as stipulated by the International Judo Federation (IJF), with the following modifications:

1. Contest area shall be 6x6 meters with 4 meter safety area between competition areas and 3 meter outside border.
2. The CARE system may be in use. If the CARE system is not in effect, three referees will be on the mat.
3. Shime-waza (choking techniques) is allowed for Shonen and Seinen Divisions (13 years and older)
4. Kansetsu-waza (arm lock techniques) will be allowed in black belt divisions only.
5. Double knee techniques will NOT be allowed in all Yonen divisions. (Direct hansoku-make – competitor will lose the match but will be allowed to continue in the tournament)
6. No Kanibasami (Flying Scissors) in any Division.
7. Pre-2003 injury rules will be observed in all divisions **except Brown and Black Belt Divisions.**
8. Any competitor who suffers a concussion (as determined by the medical staff) and/or who loses consciousness from head impact will not be allowed to continue competing in the tournament that day, in any division. If a competitor suffers such an injury, they are strongly advised to obtain a medical release from their personal physician before returning to train and compete in Judo.
9. Players who are choked out are NOT allowed to continue to compete in the tournament.
10. Modified Double Elimination and Pool System will be used.
11. Golden Score in all divisions. NO Hantei.

Match Time: 3 Minutes

1. IJF rules Regardless of Age.

Seinen (Male/Female) Brown and Black Belt Division:

Match Time: 4 Minutes

1. No White Belts
2. No kansetsu-waza (arm locks) under the age of 15.
3. IJF rules Regardless of Rank or Age

White Judo Gis are mandatory! Blue Judo Gis are optional

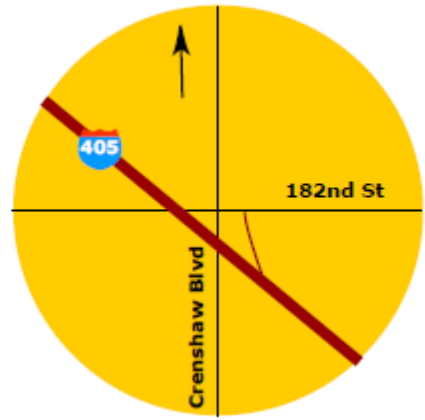

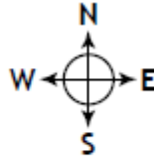

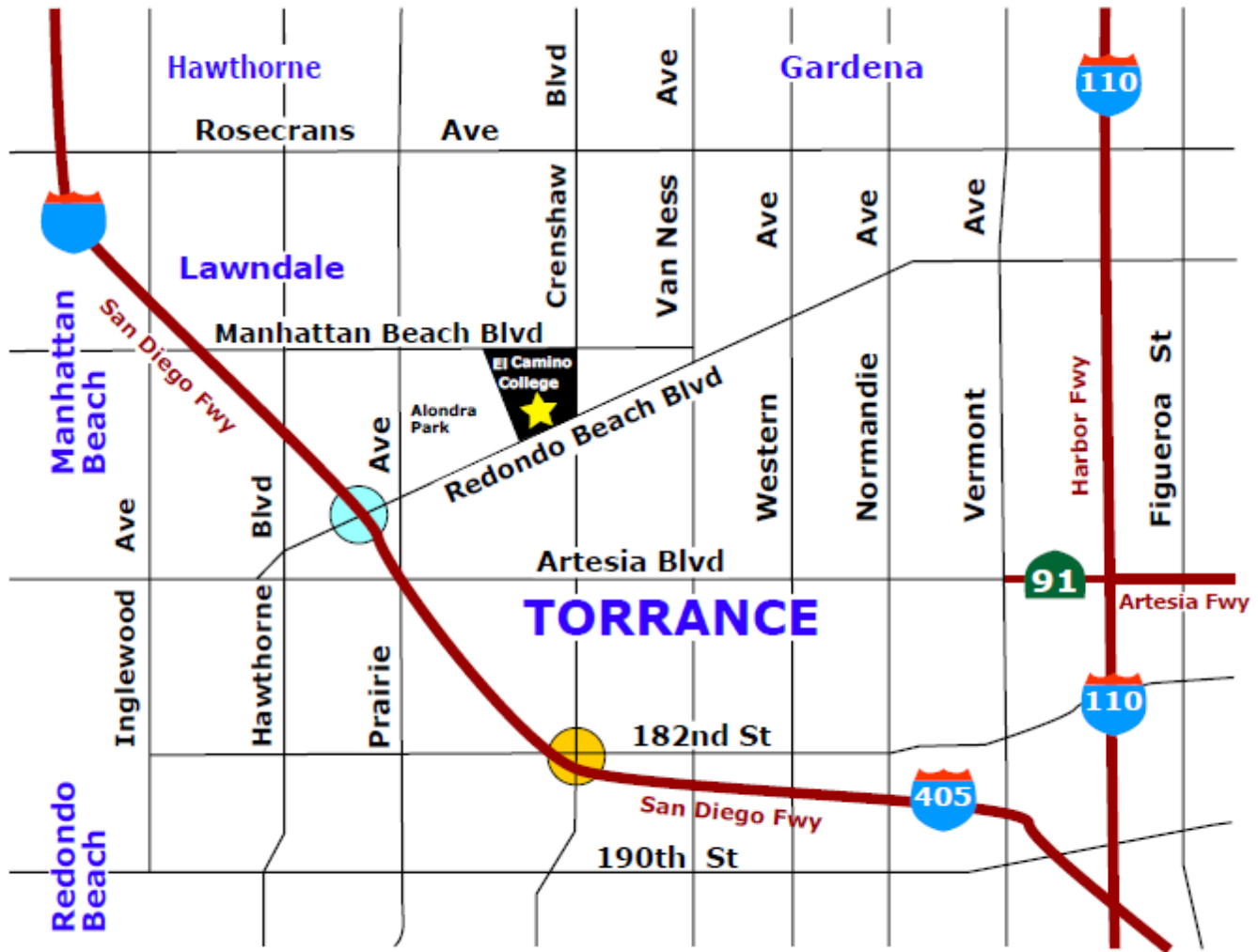
Southbound on 405:
